Executive Summary

This report provides the final projects that were approved for the Local Economic Recovery (LER) Program funding, as administered by the Queensland Reconstruction Authority (QRA).

The LER Program aims to support projects that contribute to local and regional and social recovery in areas most severely impacted by the Queensland Bushfires.

The funding is jointly provided by the Australian and Queensland governments through the Category D of the Disaster Recovery Funding Arrangements.

Recommendation

That:

1. Council acknowledge the \$3,695,205.33 grant funding for the seven projects approved under the Local Economic Recovery Program administered by the Queensland Reconstruction Authority, as detailed below:

2. Council acknowledge the funding is jointly provided by the Australian and Queensland governments through the Category D of the Disaster Recovery Funding Arrangements.

Previous Council Considerations / Resolutions

At the Ordinary Meeting held on 9 March 2021, it was resolved that:

- 1. Council commence negotiations to acquire Lots 7 and 8 on SP114284 Tamborine Mountain for future strategic purposes;
- 2. Council delegate power to the Chief Executive Officer to settle negotiations and finalise acquisition as considered necessary; and
- 3. A budget allocation for this acquisition be included within the 2020-2021 Budget.

At the Ordinary Meeting held on 12 October 2020, it was resolved that:

- 1. Council acknowledge the expression of interest that was submitted under the Local Economic Recovery Program for Council projects;
- 2. Council acknowledge the expression of interest that was submitted as a project of National Significance for Binna Burra Lodge under the Economic Recovery Program and auspiced by Council; and
- 3. Council acknowledge the detailed applications submitted for Vonda Youngman Community Centre and Boonah Cinema as requested by Queensland Reconstruction Authority.

Report/Background

Council submitted an expression of interest (EOI) for a number of proposed projects that met the criteria of the LER Funding Program, administered through the QRA.

The LER Program aims to support projects that contribute to local and regional and social recovery in areas most severely impacted by the Queensland Bushfires.

The funding is jointly provided by the Australian and Queensland governments through the Category D of the Disaster Recovery Funding Arrangements.

The EOI process closed on 7 September 2020, however, Council were given an extension until 8 September 2020 to allow for appropriate consultation to occur on one of the major projects.

Some of the projects submitted to the LER Program have previously been submitted to other grant programs, however, had been unsuccessful.

A separate EOI was submitted for Binna Burra Lodge (BBL) to rebuild this national icon. The Guidelines state that if a project is considered nationally significant then the upper limit of the LER Program of \$5 million does not apply. The BBL project was proposed in two stages and was submitted accordingly.

After the submission of the BBL EOI, the QRA contacted Council and requested an alternative project of lesser scale be submitted, also under Council's auspice.

The alternative project was successful and Council have in place with BBL a memorandum of understanding relating to works to be undertaken by BBL to deliver their project. Funding opportunities for the initial larger scale BBL project are still being sourced by BBL.

On 17 September 2020, the QRA requested detailed submissions to accompany the EOIs submitted for the Vonda Youngman Community Centre and Boonah Cinema projects. Further, in mid-November, Council was also requested to prepare and submit additional detailed submissions for the EOIs submitted for the Upgrade to Community Facilities as Places of Refuge, Supply Chain Capability Program, Tamborine Mountain Library Expansion, and the Entrepreneurial Hub program.

Other EOI projects that were submitted as detailed submissions, and which were not successful include the Regional Study Hub and Facilitating Investment in the Scenic Rim.

The QRA notified Council of successful projects as and when they had been finalised with the Grant Assessment Panel, with official confirmation generally received post the official announcements. All projects submitted have now been accessed with confirmation received for those seven projects being funded under the LER Program, (refer Attachment 1).

Funding for approved projects include the grant contribution and matched funding from Council, plus some matched funding provided by BBL for their project:

Consultation

Mayor and Councillors, Executive Leadership Team, General Manager Customer and Regional Prosperity, Grants Officer, relevant Council Officers, QRA and BBL executives have been consulted on these projects.

Conclusion

Council submitted 13 EOI projects to the QRA (12 projects to the Queensland Fund and one Nationally Significant) for consideration under the LER Program, of which nine progressed to detailed submissions phase. Council was successful in securing grant funding of \$3,695,205.33 for seven of the projects totalling \$4,945,481.33.

It is acknowledged that this funding is jointly provided by the Australian and Queensland governments through the Category D of the Disaster Recovery Funding Arrangements.

Report/Background

Council has received advice from the Department of State Development, Infrastructure, Local Government and Planning in response to its list of projects submitted for endorsement under the allocation-based and application-based component of the 2021-2024 South East Queensland Community Stimulus Program.

The following projects submitted against Council's allocation-based component have been endorsed, with all works to be completed by 30 June 2024 (in line with funding conditions):

The Queensland Government has announced an amount of \$3,990,000 has been made available to Scenic Rim Regional Council under the 2021-2024 South East Queensland (SEQ) Community Stimulus Program. The program also provides \$26 million for competitive based funding to 12 eligible south east Queensland councils.

Report / Background

The Queensland Government recently announced the \$100 million SEQ Community Stimulus Program. The grant program is delivered through a mix of base allocation funding of \$74 million and \$26 million distributed on a competitive application basis.

The aim of the grant program is to create and sustain jobs across SEQ by providing funds that enables SEQ councils to fast-track investment in new infrastructure and community assets, including investment that:

- stimulates employment now and has lasting benefits for community assets and economic development; and
- provides for economic investment in outer-urban areas or low socio-economic areas.

To be eligible for project funding under the grant program, a project must:

- be consistent with the aim of the grant program;
- achieved economic recovery/stimulus support for local communities, and creates new or sustain existing jobs in a local government area;
- be a new infrastructure or upgrade of existing infrastructure project, in one of the following categories:
 - an Essential Services Project (examples include water supply, sewerage, waste infrastructure, waste management, roads and drainage (including associated infrastructure such as footpaths, cycleways), stormwater systems, energy (including renewable energy), telecommunications / data infrastructure, disaster resilience and preparedness projects (that protect existing essential public infrastructure and/or build resilience to future natural disasters); council owned housing to be available for staff, contractors and service providers (does not include social and community housing); or
 - an Economic Development Project (examples include tourism infrastructure, town centre
 works including beautification works, saleyards, airports and aerodromes, town or city
 entrance signs / statements, caravan / tourist parks, community hubs, works depots, car
 parks); or
 - a Community Well-Being Project (examples include arts and culture, sport and recreation, library/knowledge centre, playgrounds and parks, public toilets, CCTV, swimming pools and splash parks, skate/bicycle parks, community halls).

Council has until 16 April 2021 to provide a list of nominated projects for both allocation-based funding (\$3,990,000) and competitive based funding.

Projects approved under the grant program can commence from 1 July 2021 and must be completed by 30 June 2024.

Budget / Financial Implications

Council is not eligible to use this funding as contribution towards other State or Commonwealth Government funding programs.

The funding program does not require mandatory co-contribution by Council.
