Cr Amanda Hay declared a declarable conflict of interest in Item 10.10:

"I, Councillor Amanda Hay, inform the meeting that I have a declarable conflict of interest due to the fact that some time ago I signed a petition calling for the removal of Mayor Greg Christensen and the appointment of an administrator. The sponsoring member for that petition was the Clerk of Parliament. The petition attracted 970 signatures, including my own, and I signed the petition long before former Councillor Swanborough resigned and I was elected as Councillor for Division 1.

I wish to remain in the meeting and have eligible Councillors decide if I may participate despite my likely declarable conflict of interest. The reason why I seek that approval is that I don't believe that I could be perceived by a reasonable person as having a conflict of interest which would unduly influence my decisions in this matter."

Cr Michael Enright invited Councillors to ask questions of Cr Amanda Hay.

Cr Duncan McInnes queried the approximate date of the petition. The Chief Executive Officer noted it was in approximately January 2023. Cr Amanda Hay advised it may have been December 2022 or early January 2023.

Cr Michael Enright asked Cr Amanda Hay to read the wording of the petition. Cr Amanda Hay advised it was a lengthy petition, which called for the removal by the State Government of Mayor Greg Christensen and the appointment of an administrator.

The Chief Executive Officer read the content of the petition.
