Cr Greg Christensen:

"Councillors,

I would like to bring to your attention and that of the community, the recent release of the Queensland Government's draft ShapingSEQ 2023 update - the South East Queensland Regional Plan - and the draft South East Qld Infrastructure Supplement (SEQIS) for public consultation.

The development of the SEQ Regional Plan and SEQIS has been ongoing for some time and, whilst Council officers and I have been included in some meetings, I must express my concern at the content of this latest draft document, which has been produced in the context of the current housing pressures due to South East Queensland's significant growth since 2017.

Councillors, I encourage you all to not only seek community feedback from your respective divisions but also to encourage your community members to make use of the online feedback tool to respond to these, as the draft ShapingSEQ 2023 update has long-term and wideranging implications for the Scenic Rim.

A public consultation session led by the Department of State Development Infrastructure Local Government and Planning is planned for the 7<sup>th</sup> of September at the Centre in Beaudesert. I encourage members of our community to come along and provide their feedback on this plan, which will contribute to shaping the future of our region.

The draft plan can be found on the Queensland Government website, planning.statedevelopment.qld.gov.au and will be open to community consultation until 20<sup>th</sup> September 2023."

Cr Amanda Hay declared a conflict of interest in Item 11.3:

"I declare that I have possible declarable conflicts on interest in relation to Agenda Item 11.3. These possible conflicts are, and there are three:

- 1. Former Councillor Swanborough was openly supportive of my by-election campaign in that he encouraged me to nominate as a candidate and provided a photo of us together for use on corflute signage and stated publicly that 'All things considered Amanda is my choice': and
- 2. That I was mentioned twice by name at page 15 of Attachment 1 of the Confidential attachments for this Agenda item; and
- 3. My email to all Councillors sent following the Ordinary Meeting at which the stated words 'causing harm to third parties' resulted in complaints from within Council to the OIA. Whilst the complaints were dismissed, this was the sole basis of the OIA's current and very much live investigation underway with a view to taking action to have me declared a vexatious complainant.

A 'reasonable person' may perceive that I may not be able to be impartial. Given that there are three separate matters, the cumulative effect warrants my voluntary exclusion from participating in this item, and given that I have already had one allegation of misconduct made to the OIA from within Council in relation to my alleged failure to 'fully' disclose potential conflicts, I make this declaration in the hope it will save someone the angst of making a complaint to the OIA that I did not fully disclose potential conflicts - and I state that I will now leave the meeting room and take no part in the decision or the vote on this matter.

I also believe that if anyone is aware of any potential conflicts I may have omitted, you are obliged to raise these now rather than save them up for an OIA complaint."
